

**RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK
AND INDEMNITY AGREEMENT**

I, for myself and as parent or legal guardian of my child or ward, voluntarily sign this **Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement** in consideration of the opportunity to use the facility, or to participate in any parties or activities at/by Landes Enterprises, LLC and/or Lil' Leapin' Lizard Family Adventure Center (hereinafter referred to as Lil' Leapin' Lizard). I, for myself and as parent or legal guardian of my child or ward, and on behalf of my, or my child or ward's, heirs, assigns, personal representatives and next of kin, hereby hold harmless Lil' Leapin' Lizard, its owners, affiliates, members, officers, employees, equipment manufacturers and sponsoring agencies from, and agree to indemnify Lil' Leapin' Lizard, its owners, affiliates, members, officers, employees, equipment manufacturers and sponsoring agencies, for any and all liability for any and all loss or damage, and any claim or demands therefore on account of injury to the person or property of myself and/or my child or ward, arising out of or related to use of the facility and/or participation in any parties or activities at/by Lil' Leapin' Lizard, including personal injury, disability, death or loss or damage to person or property, suffered by either myself or my child or ward, to the fullest extent of the law.

I, for myself and as parent or legal guardian of my child or ward, fully understand and hereby agree that this **Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement** extends to all acts of negligence at or by Lil' Leapin' Lizard, whether caused by Lil' Leapin' Lizard or otherwise.

I further agree that any reference to Lil' Leapin' Lizard contained within this Agreement also extends to its owners, affiliates, members, officers, employees, equipment manufacturers and sponsoring agencies.

I, for myself and as parent or legal guardian of my child or ward, agree to follow the safety instructions provided and acknowledge that failure to do so may result in expulsion from Lil' Leapin' Lizard.

I, for myself and as parent or legal guardian of my child or ward, consent to the publication of personal pictures which may be taken by Lil' Leapin' Lizard or their representative(s), and acknowledge that publication may include, but not be limited to, marketing materials and Lil' Leapin' Lizard's website.

I HAVE READ THIS RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT, FULLY UNDERSTAND THAT IT IS A CONTRACT AND FULLY UNDERSTAND ITS TERMS; UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT; AND INTEND MY SIGNATURE TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW. I VOLUNTARILY SIGN THIS RELEASE AND WAIVER AS A CONDITION TO PARTICIPATING IN ACTIVITIES AND USE OF THE FACILITIES AT LIL' LEAPIN' LIZARD, FULLY UNDERSTAND THE RISKS ASSOCIATED THEREWITH, AND AGREE TO ALL OF THE TERMS CONTAINED HEREIN.
